Purpose

The purpose of this Cell Line Information Pack (CLIP) is to communicate cell line specific information to potential users of the cell line, and to confirm that a User has received it upon the purchase of an EBISC cell line.

Information

The CLIP may provide a variety of types of information related to an individual cell line. Of particular importance are Third Party Obligations (TPOs), which are ethical or legal obligations of a Depositor related to the use of the cell line. - used to create egg or sperm cells (gametes), or embryos.

The User should consider returning incidental findings if they are clinically significant and actionable, in line with best practice and with further analysis to verify the finding where this is appropriate.

DNA sequencing can only be performed for research into donors' specified condition.

Restrictions contained in the StemBANCC Project Agreement

The Material shall not be used for Direct Exploitation. For the purposes of this Appendix 2, "Direct Exploitation" means to develop for commercialization or to commercialize the Material.
